By signing the following, I understand the cost factors and dedication that is required for participants as a Wellington Cougar All Star Cheerleader. I understand that the general costs that were mentioned at the beginning of the 2010-2011 season are a mere estimate, and within reason can change. By signing this paper, I am agreeing to take on financial responsibility for my child, or myself and also agree to schedule ANY and ALL outside appointments, jobs, meetings, etc. around the cheer schedule for one year. My dedication to the Cougars will take priority. I am aware that if these procedures are not followed I will be accountable, and may be dismissed from the squad. I understand that as a member of this squad, my behavior affects all of my team members, and that being a member of a TEAM is a huge responsibility.

1. I agree to be punctual to all cheer practices, competitions, etc.
2. I agree to attend all scheduled practices.
3. I will notify coaches of any expected absences.
4. I understand that 2 weeks prior to any competition no absences are allowed.
5. I understand all practices are closed to spectators.
6. I will set a positive example both in and out of my uniform.
7. I will always treat my fellow teammates and coaches with respect.
8. I will refrain from any unnecessary conversation during practice.
9. I will wear the appropriate practice attire to each practice.
10. I will not wear or bring jewelry to practice or any other cheer function.
11. I will keep my hair tied back with a bow and out of my face at practice.
12. I will refrain from bringing food, drinks, candy, and gum into practice.
13. I will not allow my friends or family members to distract me at practice.
14. I realize that in the best interest of the team, the coaches have the right to remove or replace a team member at any time from a position in the routine.
15. I realize that it is my financial responsibility to have tuition and competition fees on time.
16. I understand my commitment to the Cougars takes priority.
17. I realize the coaches will place me on the team they feel is best for me.
18. I assume full responsibility for the cost of all uniforms, practice attire, travel expenses, competition fees, and any other obligations.
19. I realize that my monthly tuition is due by the first of every month and will not be prorated by missed practices or time off.
20. I realize that if I choose to leave the team or am asked to leave the team, all monies are non-refundable.
21. I realize that this contract is active between June – April.
22. All team members and parents must abide by the rules set before us.

23. I understand that if at any time I should fail to follow the above contract, or act in a manner that jeopardizes the name and reputation of Wellington Cougars I may be removed from the team.

24. I understand that the coaches have the final decision, and I trust that their decision is one that is in my best interest and therefore will not be argued or discussed.
